# **Profiles of the Speakers mentioned above:**

#### 1. JOHN O'SULLIVAN CBE:

John O'Sullivan CBE is British political commentator and journalist. He is also the Vice-President and executive editor of Radio Free Europe/Radio Liberty.

He has been a senior policy writer and speech writer for Margaret Thatcher. He is the editor at large of National Review and a senior fellow at the Hudson Institute. Previously he has worked for United Press International as editor-in-chief and also for The National Interest. He was also appointed as Commander of the British Empire in the 1991 New Year's Honors List.

He is known as the founder and co-chairman of the New Atlantic Initiative which was created by Margaret Thatcher and Vaclav Havel.

#### 2. PROFESSOR NIALL FERGUSON:

Niall Ferguson, MA, D.Phil., is Laurence A. Tisch Professor of History at Harvard University and William Ziegler Professor of Business Administration at Harvard Business School. He is also a Senior Research Fellow at Jesus College, Oxford University, and a Senior Fellow at the Hoover Institution, Stanford University and the author of twelve books;

A prolific commentator on contemporary politics and economics, Niall Ferguson writes for newspapers and magazines on both sides of the Atlantic. In 2004 Time magazine acknowledged him as one of the world's hundred most influential people. He was the Philippe Roman Visiting Professor at the London School of Economics in 2010-11 and the BBC Reith Lecturer for 2012. He is a member of the board of trustees of the American Academy in Berlin, the Museum of American Finance and the New York Historical Society. His many honors and accolades include the Benjamin Franklin Prize for Public Service (2010) and the Hayek Prize for Lifetime Achievement (2012). He is Managing Director at Greenmantle LLC and serves on the Board of Directors of Affiliated Managers Group, Inc., a global asset management company.

#### 3. PROFESSOR DEEPAK LAL:

Mr. Deepak Lal works as a professor at University of California at Los Angeles for the department of International Development Studies. He is also professor emeritus of political economy at University College London and a senior member at the Cato Institute. He has been a member of the Indian Foreign service in 1963 till 1966, serving as a consultant to Indian Planning Commission, the World Bank, the Organization for Economic Cooperation and Development, various UN agencies, South Korea, and Sri Lanka.

He was also a research administrator at the World Bank. He has authored books like: The Poverty of Development Economics, The Hindu Equilibrium, Against Dirigisme and others.

#### 4. RADEK SIKORSK:

Radek Sikorsk led the student's strike committee in March 1981. He worked as a war correspondent in Afghanistan and Angola in 1986-1989. He was won the World Press Photo award in 1987 for a photograph taken in Afghanistan.

He was appointed as the Deputy Minister of National Defence in 1992. From 1998-2001 he served as Deputy Minister of Foreign Affairs and Honory Chairman of the Foundation for Assistance to Poles in the East. He was resident member at the American Enterprise Institute in Washington, D.C. and Executive Director of the New Atlantic Initiative. Radosław Sikorski was elected senator for Bydgoszcz in 2005 and served as Minister of National Defence in 2005-2007. In 2007, he was elected to the Lower House of the Polish Parliament (the Sejm) from the Civic Platform list.

He was sworn in as Minister of Foreign Affairs of the Republic of Poland on 16 November 2007. He has been Chairman of the Committee on European Affairs since 1st January 2010. He was elected Vice-Chairman of the Civic Platform in October 2010.

On 16 November 2012, celebrated in Poland as Foreign Service Day, Minister Radosław Sikorski received the rank of the Grand Officer of the National Order of the Legion of Honour, awarded by the President of the French Republic; He was also awarded the Belgian Grand Officer's Cross of the Order of the Crown on 4 September 2013;

On 22 October 2013, he was awarded the Presidential Order of Excellence by Georgia's President Mikheil Saakashvili.

#### 5. LORD POWELL KCMG:

Lord Powell KCMG served as a private secretary and advisor for foreign affairs and defence to British Prime Minister Margaret Thatcher and John Major. He is currently a member of the House of Lords serving the Select Committee on the constitution. He also chairs the Government's Asia Task Force.

He has served numerous company boards such as Louis Vuitton Moet Hennessy in France, Caterpillar and Textron in US, Hong Kong Land and Mandarin Oriental Hotels in Asia and Schindler Group in Switzerland. He is also the Chairman of the International Advisory Council of Rolls-Royce and serves multiple International Advisory Boards which include Barrick Gold., ACE and the Council on Foreign Relations in New York.

He is one of the Trustees of the Aspen Institute in the US as well as of the British Museum, the International Institute for Strategic Studies and Atlantic Partnership of which he is the chairman. Lord Powell is also a member of the Ashmolean Museum in Oxford.

#### 1. DR PIPPA MALMGREN:

Dr. Pippa Malmgren heads a firm known as DRPM Group. She partly owns and serves the board of H Drones which is also now a part of DRPM Group.

She has contributed and still does to various organizations such as the British Ministry of Defence Working Group on Global Strategic Trends, the Greater London Authority Infrastructure Advisory Board, the Economic Advisory Board to the Prime Minister of Malaysia, the Legatum Institute at MIT and Indiana University School of Public Policy and Environmental Affairs.

In past, she worked as financial market advisor to the President in the White House and on the National Economic Council from 2001-2002. She has also been a member of the President's Working Group on Financial Markets and the Working Group on Corporate Governance.

#### 2. DR ART LAFFER:

Dr. Arthur B. Laffer is the founder and chairman of Laffer Associates, an economic research firm. He currently sits on the board of directors of several public companies, which include: MPS Group Inc. (MPS) and Oxigene Inc. (OXGN). He also sits on the board of directors Nicholas Applegate Institutional Funds; Retirement Capital Group; Pillar Data Systems; LifePics; Jovian Holdings; Roth Capital; Atrevida Partners; Health Edge Partners; First Q Capital; The Mayfair Group; and Endovascular Instruments. In the past, he has served on the

board of directors of Veolia Environnement; Provide Commerce; Neff Corporation; Petco; Clarcor and Amplicon Financial.

Dr. Laffer is a founding member of the Congressional Policy Advisory Board, a select group of advisors who assist in shaping legislative policies for the 105th, 106th and 107th United States Congress. Dr. Laffer was a member of President Reagan's Economic Policy Advisory Board for both of his two terms (1981-1989). He was a founding member of the Reagan Executive Advisory Committee for the presidential race of 1980. He also advised Prime Minister Margaret Thatcher on fiscal policy in the United Kingdom during the 1980s.

In his lists of awards and honors, rest two Graham and Dodd Awards from the Financial Analyst Federation for outstanding feature articles published in the Financial Analysts Journal; the Distinguished Service Award by the National Association of Investment Clubs; the Adam Smith Award for his insights and contributions to the Wealth of Nations; and the Daniel Webster Award for public speaking by the International Platform Association. Dr. Laffer also earned the Father of the Year award from the West Coast Father's Day Committee in 1983.

#### 3. PROFESSOR DEIRDRE MCCLOSKEY:

Deirdre Mccloskey is a Professor at the University of Illinois at Chicago, teaching Economics, History, English, and Communication. She is a reputed economist, rhetorician and a historian. Her achievements include sixteen books and around 400 scholar articles on diverse topics such as technical economics and statistics to transgender advocacy and the ethics of the bourgeois virtues.

She has contributed to topics like British economic Failure in the 19<sup>th</sup> Century, trade and growth in 19<sup>th</sup> Century, open field agriculture in the middle ages, the Gold Standard, and the Industrial Revolution. "The Rhetoric of Economics", "You're So Smart: The Narrative of Economics and Persuasion in Economics" add up to her list of Philosophical books.

#### 4. JOHN MICKLETHWAIT:

John Micklethwait is the Editor-in-Chief of The Economist. He received his degree in History from Magdalen College, Oxford. Before he became a member of The Economist he worked as a Banker at Chase Manhattan. He worked at The Economics as finance correspondent, later working as Business editor and United States editor.

He has co-authored with Adrian Woldridge, five books. He was named Editor's editor by the British Society of Magazine Editors in 2010. He is one of the trustees of the British Museum.

## **Professor Luigi Zingales**:

He teaches Finance at the Chicago Booth University and has authored two books: Saving Capitalism from the Capitalists and his more recent work, A Capitalism for the People: Recapturing the Lost Genius of American Prosperity. He's the director of the American Finance Association and has co-designed the Financial Trust Index. He has indulged in discourses on political economy and corporate finance. His work in finance earned him the 2003 Bernacer Prize for the best young European financial economist. His latest pursuit is related to finding a way out of the latest financial crisis.

# **Speaker Profiles:**

#### 1. BARONESS GREENFIELD:

Susan Greenfield is a neuroscientist, writer, and broadcaster. She has been awarded 30 Honorary Degrees from British and foreign universities and heads a multi-disciplinary research group exploring novel brain mechanisms linked to neurodegenerative diseases such Alzheimer's and Parkinson's. She is a Senior Research Fellow at Lincoln College, Oxford and has currently co-founded a biotech company developing a novel approach to neurodegenerative disorders (Neuro-Bio Ltd).

In 1998 she received the Michael Faraday Medal from the Royal Society, was awarded a CBE in the Millennium New Year's Honors List and was granted a non-political Life Peerage in 2001.

She was the Chancellor of Heriot Watt University in 2005.

Further accolades for her include L'Ordre National de la Légion d'Honneur from the French Government, and the American Academy of Achievement Golden Plate Award, both received in 2003. Susan was also awarded the Australian Medical Research Society Medal in 2010.

In 2011, Susan served the Advisory Board of the Kusuma School of Biological Sciences at the Indian Institute for Technology, Delhi. In addition, she has published a neuroscientific theory of consciousness,' The Private Life of the Brain' (2003)

In 2012, Susan was offered the Honorary Fellowship of the Institute of Risk Management and also became a Vice Patron of POWER International.

In 2012, Susan was selected to serve as the Parliamentary Patron of the Westminster Higher Education Forum, meanwhile also continued to be a Parliamentary Patron of the Westminster Education Forum.

#### **Stephen Sackur:**

Before taking over on the BBC News Channel and BBC World flagship current affairs interview programme, he had been based in Brussels for three years as the BBC's Europe Correspondent.

Prior to this, Stephen was the BBC's Washington Correspondent from July 1997.

He has interviewed Presidents George W Bush and Bill Clinton, covered the 2000 US Presidential Elections, the Clinton scandal and impeachment trial.

Stephen has also been the BBC Middle East Correspondent in both Cairo (from 1992 to 1995) and Jerusalem (from 1995 to 1997), covering the peace process, the assassination of the Israeli Prime Minister Yitzhak Rabin and the emergence of the Palestinian Authority under the late Yasser Arafat.

Stephen was appointed as a BBC Foreign Correspondent in 1990. He was part of the BBC's team of correspondents covering the Gulf War, spending eight weeks with the British Army when the conflict began

#### MICHAEL CLARKE:

Professor Michael Clarke is currently the Director General of the Royal United Services Institute. Until July 2007 he was Deputy Vice-Principal and Director of Research Development at King's College London, where he is now also Visiting Professor of Defence Studies. He was, from 1990 to 2001 the founding Director of the Centre for Defence Studies at King's. He was appointed Professor of Defence Studies in 1995. He was the founding Director of the International Policy Institute at King's College London from 2001-2005 and Head of the School of Social Science and Public Policy at KCL in 2004-05.

He has previously taught international politics at the Universities of Aberystwyth, Manchester and Newcastle upon Tyne, and also at the University of New Brunswick, and the Open University. He has been a Guest Fellow at The Brookings Institution, Washington, DC, and a Fellow in Foreign Policy Studies at the Royal Institute of International Affairs in London.

In 2009 he was appointed to the Prime Minister's National Security Forum and in 2010 to the Chief of Defence Staff's new Strategic Advisory Group. He also serves on the Strategic Advisory Panel on Defence for UK Trade and Industry.

His recent publications include: The Afghan Papers: Committing Britain to War in Helmand 2005-06, London, RUSI/Routledge 2011; United Kingdom: Strategic Posture Review, World Politics Review, November 2011; 'Does War Have a Future? in Lindley-French and Boyar eds., The Oxford Handbook of War, Oxford, OUP, 2012.

#### **GENERAL DAVID PETRAEUS:**

General David Petraeus headed the American military in Iraq during 2007-2008 and also commanded forces in Afghanistan from 2010 to 2011.

He graduated from the U.S Military Academy at West Point in 1974 and earned degree in Public Administration and International Relations from Princeton's Woodrow Wilson School of Public and International Affairs.

He led the 101<sup>st</sup> Airborne in the 2003 attack on Saddam Hussein's regime in Iraq. He was also appointed as the trainer for the new Iraqi Army from June 2004 till September 2005. He became the commander of the Multi-National Force-Iraq in February 2007. He was later appointed as U.S Central Command, looking over the operations in Central Asia and Middle East. Furthermore in June 2010 he was made the commander of U.S forces in Afghanistan and departed his position in August 2011, taking over the position of Director of the CIA, which he resigned from on November 9, 2012.

#### **DR KEYU JIN:**

Dr.Keyu Jin is a professor of Economics at London School of Economics. She holds expertise in International Macroeconomics, International Finance and the Chinese economy. Her academic publications include "American Economic Review", the "Journal of International Economics" and the "Encyclopedia of Financial Globalization". She is known for her consultation for the World Bank, the IMF, the New York Fed, Goldman Sachs, Morgan Stanley and JP Morgan.

#### **JOHN HOWARD OM AC SSI:**

John Winston Howard AC, SSI, was the 25th Prime Minister of Australia, from 11 March 1996 to 3 December 2007. He was the second-longest serving Australian Prime Minister.

Howard was a member of the House of Representatives from 1974 to 2007, representing the Division of Bennelong, New South Wales. He served as Treasurer in the Fraser government of from 1977 to 1983. He was Leader of the Liberal Party and Coalition Opposition from 1985 to 1989.

In 2010, John Howard was also nominated as the Australia and New Zealand candidate for the ICC.

#### **RICHARD BARRONS:**

Major General Richard Barrons was commissioned into the Royal Regiment of Artillery in 1977, prior to reading for a degree in Philosophy, Politics and Economics at Queen's College, Oxford. He then served in a variety of regimental appointments based in the UK and Germany, which included periods of training in Belize, Canada, France, Hong Kong and Brunei, and two years at the MoD, London.

He was appointed Chief of Staff of the Allied Rapid Reaction Corps in April 2009. In October 2009 he was posted at very short notice to HQ ISAF to establish a Force Reintegration mechanism.

He was appointed MBE in 1993, OBE in 1999, CBE in 2003, awarded QCVS in 2004 and 2006, and appointed as an Officer of the US Legion of Merit in 2009.

#### **FREDERICK J RYAN JR:**

Frederick J Ryan Jr. has worked from online and print journalism to broadcast and cable television stretching out his career to public diplomacy and non-profit and public service.

He is the President and CEO of POLITICO and COO of POLITICO publisher Allbritton Communications Company. He serves the ASCJ Board of Councilors. He has edited books like "Ronald Reagon: The wisdom and Humor of the Great Communicator" and "Ronald Reagan: The Great Communicator"

He has worked at senior-level positions in the White House during Reagan's administrations. Furthermore he has also worked as Director of the White House Private Sector Initiatives program.

He remains the chairman of the Library Foundation's Board of Trustees. Initially also working for The Gipper's California offices and the Ronald Reagan Presidential Library and Center for Public Affairs.

#### **FRASER NELSON:**

Fraser has served many nonprofit organizations for more than 25 years ranging from places as Appalachia and New York City. Her work mainly revolves around civic welfare.

She served Utah's Disability Law Center for 10 years. In 2008 she along with Greg Warnock founded the Community Foundation of Utah. She is also the immediate past president of Utah David Eccles School of Business. In 2011, she worked as the first Professional in Residence at the University's Center for Public Policy and Administration.

#### JOHN HOWARD OM AC SSI:

John Winston Howard AC, SSI, was the 25th Prime Minister of Australia, from 11 March 1996 to 3 December 2007. He was the second-longest serving Australian Prime Minister.

Howard was a member of the House of Representatives from 1974 to 2007, representing the Division of Bennelong, New South Wales. He served as Treasurer in the Fraser government of from 1977 to 1983. He was Leader of the Liberal Party and Coalition Opposition from 1985 to 1989.

In 2010, John Howard was also nominated as the Australia and New Zealand candidate for the ICC.
